PUBLICATION OF THE ISO 14083 STANDARD

The ISO 14083 standard – "Greenhouse gases — Quantification and reporting of greenhouse gas emissions arising from transport chain operations" was published by the ISO Committee on 20 March 2023, after around three and a half years of preparation.





EC WORKSHOP ON IMPACT OF DIGITALISATION/AUTOMATION ON TRANSPORT WORKFORCE

On 21 March, CLECAT participated to the Commission's stakeholder workshop on the impact of digitalisation and automation in the transport workforce.
