CLECAT FEEDBACK ON NON-EU TRANSHIPMENT PORTS IN DRAFT IR ETS MARITIME

On 18 September, CLECAT submitted its feedback to the Commission on the draft Implementing Regulation identifying neighbouring container transshipment ports. According to the recently revised ETS Directive and more specifically the inclusion of maritime emissions into the EU ETS, the Commission has been tasked to draw up a list of non-EU ports close to EU ports and mostly used for transshipments which would be excluded from the definition of port of call.
